July 6-8, 2012 Oklahoma City, OK 121<sup>st</sup> Western District Conference Annual Assembly Theme: BECOMING ONE IN CHRIST TO BE SENT Meridian Convention Center, Oklahoma City, OK Saturday, July 7, 2012

### Delegate Session

- I. Worshipful Work Team:
  - A. Esther Vasquez opened the meeting with a personal story and invited folks to name their emotions. The worship team led the body in singing.
  - B. Lou Gomez invited the group to think of someone who has been influential in our lives and shared a personal story.
  - C. Miles Reimer read from Philippians 2 as preparation for silent prayer.
  - D. The worship team the body in "Let me be your servant."
- II. Doug Penner, moderator, called the meeting to order. He outlined the meeting.
- III. Credentials Committee Report: Charlotte Warkentine presented the report. There are 63 churches and 5 church plants in WDC with 358 eligible votes. Number of church or church plants represented is 54 (55). Number of delegates represented at the assembly are 217 (219). Number of votes represented are 337 (339). Number of churches/church plants not represented 14 (13). Number of votes not represented 21 (19). (Note corrected numbers in parenthesis.—Nancy Funk, WDC Administrative Assistant, 7/26/12)
- IV. Resolutions Committee introduction: Brenda Glanzer Lilliston, Jay Goering, Steve Schmidt.
- V. Accept minutes of Annual Assembly 2011: Berni Kaufman
  - MOTION: To accept Bob Poulseen/ Guy Smoker)
- VI. Budget: Phyllis Regier
  - A. The audit was completed on June 29. It is available upon request.
  - B. Income exceeded expenses by \$2,320.
  - C. Phyllis explained Camp Mennoscah's budget. Income over expenses was \$29,990.
  - D. 2013 Budget was presented and explained.

## MOTION: To accept the 2013 budget. Approved.

- VII. Election: Al Penner, Gifts Discernment Committee, introduced other members from the committee.
  - A. The slate was presented.
  - B. Nominations from the floor were called forth. None.

MOTION: To accept the slate of officers. Ballot vote. Motion passed. Subsequent tally of ballot votes indicated that all nominees were elected by strong majorities.

- VIII. Acceptance of Iglesia Menonita Casa de Dios into membership: Gilberto Flores
  - A. Gilberto introduced members of the congregation present who came to the stage.
  - B. Gilberto asked questions of Pastor J. Natividad Hernandez regarding the churches beginning and vision.

MOTION: To accept Casa de Dios into membership of WDC. The acceptance of membership was approved by standing and applause of the body.

C. Clarence Rempel presented the pastor a certificate of membership and copies of the booklet, "Que es un cristiano anabautista?" or "What is an Anabaptist Christian?" by Palmer Becker.

### IX. Resolutions: Doug Penner

- A. Doug outlined the procedure for bringing resolutions to Assembly. He reviewed the amendments and voting procedure.
  - 1. Presentation of resolution: Max Fugua, Inman Mennonite
    - a. Max gave a brief history from which the resolution was made.
    - b. The resolution was discussed within the congregation and the congregation agreed to bring the following resolution.

### 2. Questions of clarification

- a. In the review, Max used the phrase same sex marriage. This is not legalized in Kansas. What was meant? Same sex covenant.
- b. Is there a copy of the membership guidelines? There is a copy on one of the front tables.
- c. Which Leadership Commission would follow through? The current Leadership Commission would convene.
- d. Length of suspension? Two-year suspension.
- e. Suspension means that the pastor should no longer serve in his/her congregational capacities. How does this relate to membership in the Corinthian Plan? Not able to answer that question.
- f. What is the expectation of the remedial steps? Bethel Mennonite has no expectations. That is in the hands of the Leadership Commission.
- g. If the Leadership Commission were to meet and decide the same thing that Joanna's credentials are in order, will that satisfy the resolution? No, the only conclusion would be to find her credentials not in order.
- 3. Presentation of resolution: Oklahoma congregations, David Wiens
  - David expressed concern that it seems The Confession of Faith (COF) is not followed.
  - b. David explained the conviction of the three Oklahoma churches. The COF should be used as a standard to bring us to unity.

### 4. Questions of clarification

- a. If the resolution is adopted, how will it be enforced? Begin with the Scripture. If the COF is already spoken, there is no need to speak again.
- b. How does this differ from Article II in our current bylaws? It is a refocusing.
- c. How will resigning be enforced? If we have a major conflict with the COF, we should leave the conference. We need to act out of conscience.
- d. Is the intent that if a pastor doesn't believe in pacifism, that pastor should resign? The appeal is to make a decision based on conscience.
- e. Who determines what is classified as a major issue or minor issue of disagreement with The Confession of Faith?
- f. In the future, when a new COF is drawn up and 20% disagree, are they expected to leave the conference? If there are persons who, out of conscience, can't agree, they would leave. The resolution is dealing with leadership.
- g. How did you come to the conclusion that this is a major conflict with the COF? What about a pastor who supports war? The Leadership Commission makes that decision.

- h. The original resolution to accept the COF was as a teaching document. Would you accept this as a teaching document? Yes. If we don't use this as our standard, what do we use?
- B. Worshipful Work Team led the group in prayer.

C. Action on resolutions: Doug Penner

Resolution 1: Bethel Mennonite Church, Inman, Kansas moves that the Leadership Commission reverse their decision in which they stated "We find Joanna Harader's credentials to be in order" and instead suspend the credentials of Joanna Harader.

### MOTION: To accept the resolution (Max Fugua/Jerry Pankratz)

- 1. Open mike comments
  - a. If the new LC were to find Joanna's credentials in order, the delegate body would be substituting for the LC action.
  - b. The COF is a teaching document and move to table the motion. A motion to table would require a two-thirds majority later corrected to simple majority. Is there a second? (Dave Habeggar/David Orr) This relates to resolution 2 and is out of order.
  - c. Let's love all our neighbors with love and compassion.
  - d. Not all at Lawrence agreed with Joanna's decision but did affirm her process of coming to the decision. A member of the congregation shared the breadth of Joanna's ministry.
  - e. The COF was agreed upon. Gay marriage is deemed a sin. We should abide by the COF. Let's stop smoothing things over and do what Jesus would do.
  - f. Joanna is an outstanding pastor who takes her charge very seriously. Before she decided to go ahead with the ceremony, she did a lot of study, prayer and talked with people. She informed the church, the conference minister and performed the ceremony and said she would do it again based on her scripture study.
  - g. Sin is turning away from God. We sin by separating ourselves and others from God. Joanna did not do this.
  - h. A person from her congregation said that he would be sickened to lose Joanna.
  - i. Just being good doesn't get us into heaven.
  - j. Concern that some have said that this is an issue between biblical people and unbiblical people. The Bible says to love one another as you love yourself. We can't lump Joanna and those in sympathy
  - k. The Spirit was present when the LC made their decision. The Spirit was present when Lawrence Mennonite made their decision. My fear is that this resolution would damage action made by a committee or commission.
  - What would actually implication of putting this resolution in practice? The LC
    went on record last year that they would not reverse their decision. If Inman were
    to rewrite the motion, they would say that the delegate body would reverse the
    LC decision.
  - m. No one left Peace Mennonite Church even though they didn't agree with Joanna's decision. Allow congregations to discern,
  - n. Lorraine Mennonite has a welcoming statement stating they will welcome gay and lesbians. What does the passage of this resolution mean for this church in the future?

Amendment 1: We, from Lorraine Avenue Mennonite Church, move that the LC revise the statement regarding Joanna Harader's credentials as follows: "We find Joann Harader's credentials to be in order. However, it will be noted on her Ministerial Leadership Information form that her action in performing a same-sex union is at variance with the Mennonite Church USA's Membership Guidelines." (second: Janet Kaufman)

### Questions of clarification:

- Bethel Mennonite discussed the amendment and are not in favor. This states that the delegate body states that they find Joanna Harader's credentials to be in order.
- Joanna has made it clear that she will do it again. Would the amendment allow for the number of times she would perform a union? Yes.

# MOTION: To accept the amendment. Ballot vote. Yes- 184, No- 154. Amendment passed.

We, from Lorraine Avenue Mennonite Church, move that the LC revise the statement regarding Joanna Harader's credentials as follows: "We find Joann Harader's credentials to be in order." However, it will be noted on her Ministerial Leadership Information form that her action in performing a same-sex union is at variance with the Mennonite Church USA's Membership Guidelines." (second: Janet Kaufman)

AMENDED MOTION 1 Lorraine Avenue Mennonite Church, Wichita, Kansas: We move that the Leadership Commission revise the statement regarding Joanna Harader's credentials as follows: "We find Joann Harader's credentials to be in order." However, it will be noted on her Ministerial Leadership Information form that her action in performing a same-sex union is at variance with the Mennonite Church USA's Membership Guidelines." (Mike Fetters/Janet Kaufman)

### Discussion

Amendment: insert the word "not" to read We move that the LC revise the statement regarding Joanna Harader's credentials as follows: "We find Joann Harader's credentials to not be in order." However, it will be noted on her Ministerial Leadership Information form that her action in performing a same-sex union is at variance with the Mennonite Church USA's Membership Guidelines." (Gary Regehr/Bill Froese)

Motion to table the amended motion. (Dave Habegger/Bill Klassen).

A point of order was made that Roberts Rules of Order state that to insert the word "not" after the word "to" cannot be inserted which would negate a motion. The moderator declares the amended motion to Amended Motion 1 is out of order.

Vote on the amended resolution 1. Ballot vote. Yes- 203, No- 136. Amended Resolution 1 is adopted.

Action on resolution 2

**RESOLVED:** That the leadership of Western District Conference, including the Executive Board, the Commissions, Committees and District Ministers, acknowledge as official position the current **Confession of Faith in a Mennonite Perspective** 

That those in the above leadership positions, pastors, and or congregations conduct their functions and business in accordance with that Confession of Faith and that those who cannot do so according to their conscience resign their positions of leadership and influence in the Western District Conference.

MOTION: To accept the resolution. (Dave Wiens/Bob Sprunger)

1. Open mike comments

MOTION: To table the resolution. (David Habegger/Guy Smoker) Ballot vote. Yes  $-\,$  170, No- 167 . Motion is adopted .
